To our dear friends and supporters,

It is beyond our ability to properly thank you enough for all that so many of you have done for us. We have seen and experienced the best of God's people towards us. Our only consolation is that the Lord knows and rewards the many churches and individuals who have provided for our needs in ways big and small. It has also been our distinct honor and privilege to meet the many church members, pastors, pastors' wives, preachers, and missionaries along our way. We began deputation in June and over the past four months we have been in fifty-seven churches and meetings with an additional sixteen meetings scheduled through Nov 19th. Lord willing, we will be able to schedule a few more in Nov, but so far, so good.

We have done our best to stay on the road and in as many churches as we can. I am convinced that in doing so we honor the Lord through obedience and tenacity, as we work to show ourselves faithful to His directing in our lives. The effort may be ours, but the results are entirely His. Thus far, approximately two-thirds of the fifty-seven churches we have visited have verbally agreed to support us, with many of those having already begun to do so.

With that in mind, we have arrived at a place where we are required to change our plans, but with good reason. As many of you know, our son Caleb and his wife Bella are filling in for us on Guam and are expecting a baby. However, on Guam, finding appropriate medical care can be challenging and the waiting lists for appointments can be quite long. Because of this, and some potential complications with her health, Caleb and Bella will be traveling back to the states in early December, which has hastened our return to Guam and shortened our anticipated departure date from the states by about six months.

While not in our plans, we are convinced that God still has control, and that nothing catches Him off-guard. Our current financial support level is approximately 35%, and we covet your prayers together with us as we wait to see how the Lord moves us forward.

On island, there is good and bad news. First, the good: a 10-year-old Chuukese boy, named Joshua was saved Wed the 1st of Oct. Caleb and Joshua called and gave us the good news this past Wednesday. His testimony was clear, and we rejoiced! In the past 6 months, I believe a total of seven people have been saved.

The bad: a large family, whose children usually ride the bus to church, has suffered a major disruption requiring social services to be involved. Currently, five of the children are in the care of the Gov't of Guam Social Services. Upon our arrival back on Guam, we will work to see if we can provide foster care in some way as these children are very dear to our hearts, and we ask that you beg the Lord with us for the sake of this family and these precious children.

As you can imagine, our emotions are mixed. We miss our home and our church on Guam, but our situation has obligated us to leave the states prematurely, unable to fully complete our deputation. I will send out an update before that we leave for Guam, but in the meantime, please keep us in your prayers... prayer moves the hand that moves the whole world.

One last item, by January, Bro. Elwood Hurst, who basically started our church on Guam 30 years ago, is coming back to Guam to assist us in the ministry. We are very excited about this and trust that the Lord will be glorified in all that we do.
